- 3. I understand that in order to receive an annual allocation of water to the structure described above, I must comply with LAWMA's Bylaws, rules, and policies, including by making timely payment of all required fees, dues, and assessments; and with the terms and conditions of this Application.
- 4. I understand that any water supplied to me by LAWMA for augmentation purposes was partly or wholly obtained with a loan from the Arkansas River Augmentation Loan Account. Under C.R.S. § 37-60-130, LAWMA members that accept the benefits of that loan must agree to cease diverting water at the augmented member structure if they fail to pay membership dues. I understand that by acquiring a LAWMA membership for augmentation of diversions at the structure described above, I will have accepted the benefits of this loan account. Accordingly, I hereby agree to immediately cease diverting water at the above-described structure if I fail to make full payment of my membership dues and share assessments. I acknowledge that C.R.S. § 37-60-130(4)(a) requires the State Engineer to promptly and completely curtail my use of the above-described structure if I fail to make full payment of my membership dues or share assessments.
- 5. I hereby agree to comply with any and all State of Colorado and/or Division Engineer rules, regulations, and policies governing the measurement of ground water withdrawals and the use of such ground water in the Arkansas River Basin.
- 6. I hereby agree to comply with the terms and conditions of any water court decree or administrative approval pertaining to LAWMA's use of its water rights or to use of the structure described above.
- 7. I hereby agree to abide by the terms and conditions of this Application, LAWMA's Bylaws, and all rules and policies adopted by the LAWMA Board of Directors.
- 8. I understand and hereby agree that upon the LAWMA Board of Directors' approval of this Application, I must enter into a reimbursement agreement, in the form attached as Exhibit A, before LAWMA will act to include the above-described structure in any LAWMA augmentation plan, Rule 14 plan, substitute water supply plan, or replacement plan, and before the above-described structure will be eligible to receive an allocation of LAWMA water.
- 9. If the above-described structure is powered by electricity, I hereby authorize the utility identified in Part 2.5.a above to provide the structure's power records, including meter records, to the Division Engineer and to LAWMA.
